Registration: Keep a copy of registration form for your records. Full payment must be received with registration form. Checks are cashed as received. **NO REFUNDS.** Confirmation letters will be sent by email.

Amenities: No admission or parking fees, 50,000 sq. ft. of inside shopping area, multiple entrances, all areas have traffic. Inside or outside booths available, electricity for booths against wall (note below). Concession and eating area. Restrooms inside and outside.

Vendor Set-up: Friday @ 8:00 am – 8:00 pm, Saturday @ 7:30am - 8:30 am **Open for business @ 9:00 am**, Sunday @ 9:00 am for vendors and we **Open to the public @ 10:00am**. Booth assignment announced just prior to the show unless pre-registered the previous year. Check-in at the Arena area – glass doors facing Telge. After unloading, park on the fence lines or near the outdoor rodeo arena, away from the building, to allow close parking for customers. The cars also draw attention to the facility out closer to the road. **VENDORS MUST BE OUT BY 7 PM ON SUNDAY NIGHT.**

Vendors must furnish: Display tables & chairs, tablecloths, extension cords & power strips must have GFI switch, fans (bldg is not Air Conditioned). No canopies on frames inside. Must donate one tax deductible raffle/silent auction item. Please deliver your donation item prior to 9:00am Saturday. Donation forms will be provided via e-mail and at check-in.

WI FI/Hot Spot: Vendors will be responsible to provide their own internet connection.

JV FFA Booster Club (BC) Restrictions: BC may limit number of booths selling the same products; may ask for removal of items not listed or deemed appropriate for venue. Booster Club may re-sell the booth, if a vendor is not ready to open by 9:00am Saturday. **Vendors may not re-sell their booth.** If we sell out and are unable to provide space, vendor will receive voided check or full refund. This is a CFISD school district property and district policies apply.
